- Ammunition shot size must be 7 1/2, 8 or 9 and not over 1 1/8 ounces.
- Carry shotguns with the muzzle either pointed up or down.
- The Toby Keith Foundation reserves the right to alter or cancel any part of this program, refuse entry or cause withdrawal of any shooter or team, if conditions warrant.
- No alcohol prior to or during shooting event.

Registered shooters will receive 100 targets, 100 rounds of ammo (*provided by Black Hole Ammo*), golf carts, food and drinks.

NOT PROVIDED: EYE AND EAR PROTECTION.

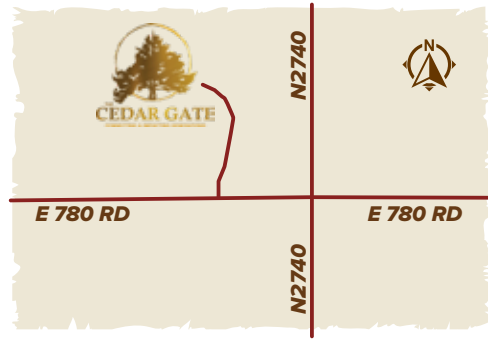
